# 2) Minutes of previous meeting of 23<sup>rd</sup> April`07

These were accepted as correct by all.

#### 3) Matters arising

- a) BEV the May issue has been a success and a date for all entries for the next edition was fixed see 6 below.
- b) Walkabout this took place on 16<sup>th</sup> May with support as usual from Jackie Lane. The new trees were checked and overgrown bushes will be dealt with by the Highways Department. Arthur had mentioned some bushes that needed attention, together with a faulty letter box and these have already been dealt with. Roy suggested that another Walkabout be arranged for the Autumn. Arthur had taken the registration numbers of two cars that continually park on the grass in Petrel Way and these will be given to the appropriate person.

#### 4) Financial Report

John reported a balance of £855.21 in the TKRA account and £73.77 in the Neighbourhood Watch account. John explained, for the benefit of the new committee members, that the TKRA account included a sum of money collected to fund any action that might be necessary in our protest of the mobile phone mast. No invoices have been received from the printers re. BEV and John felt it can be assumed that some issues have been written off. A cheque for £5 has been received from Mr. Curley.

#### 5) Neighbourhood Watch

Peter reported that several people had volunteered to take part in the Community Speed Watch scheme. Training will be given to those wanting to take part. The speed gun will be shared with Galleywood. SID is now back in operation. In May two cars on the estate had been vandalised. Apparently this kind of damage is common in Springfield although even there the incidents are reducing. There is now another spate of problems with Mini Motor Cycles in Chelmer Park. In Goshawk Drive an accident had occurred because of commercial vehicles parking on the side of the road. Peter asked that the problem of parking on the roads again be reported since

it is a problem continually, and rightfully, being reported by residents. Pcs Strange said she is constantly advising residents of the danger of parking on roads, especially

on corners, and she has asked several to move their vehicles. A request had been received from a representative of the Police to advertise in BEV.

A decision will be made as to whether to merge the two committees (ML and TK) plus NAP. Attendance at the NAP meeting is by invitation only whereas the ML&TK is an open meeting. Cycle tagging is to take place on Friday afternoon at Moulsham School. The new committee NAP will make the tackling of youth problems in the area a "priority".

#### 9) **Any other business**

- a) Both Dave Ashford and Clare Hall showed interest in assisting Arthur in the editorial of the next BEV and Arthur talked through what is involved and it is hoped that a new editor has been found.
- b) Peter asked for the e-mail addresses, postal addresses and telephone numbers of the three visitors.
- c) Adrian asked for copies of the Minutes in order that he can put these on the website once they have been approved by the Committee.
